We experienced two unrelated cases of Leber's hereditary optic neuropathy (LHON) in Japanese. The optic nerve atrophy was milder than that of the Caucasian patients. The auditory brainstem responses (ABRs) were initially normal or nearly normal in both cases. Their cognitive development was normal until the age of 10 to 11 years. One case showed a delay in language acquisition. ABRs were found to be significantly delayed in the second patient, although the audiologic signs were not, until the age of four. Various forms of brain imaging studies failed to reveal any abnormality in both patients. Our experience and literature reports are discussed together with the concept of the etiology of LHON.

Roe v. Wade: How an American law has shaped history On Jan. 22, 1973, abortion was legalized on a national level, and an American legal challenge to Roe v. Wade was history. Although some of the case's participants may have been aware that they were dealing with a major constitutional decision, the Supreme Court just announced their decision without any forewarning. The justices said that the Texas law, which some interpreted as trying to ban all abortions, could not stand the scrutiny of a court, because Roe v. Wade was the law of the land. Roe v. Wade was never the intention of the justices, but it has affected history and the U.S. political culture with a pernicious permanency. It was, in fact, an error on the court's part that led to this development. On a 1982 appeal of the Roe v. Wade decision, the court clarified that it was only questioning the requirement that states must permit the right to abortion in the first trimester. This was mentioned in the original opinion but didn't influence the decision. Since then, the court has been challenged by some well-intentioned lawmakers. More than 30 states have passed laws (or state constitutional amendments) in recent years to limit abortions, but in each instance, the Supreme Court has overturned the law. The Roe v. The newly formed Trinamul Congress won 99 of the 126 seats in the elections, except for 2 seats where it lost to the Communist Party of India (Marxist). 2017 election Mamata Banerjee became the Prime Minister of West Bengal in January 2017 by winning a confidence motion in the state assembly. She had a narrow majority in the House. She became the first female leader of a state in India.
